RESOLUTION NO. 2018-18-017

EARNESTLY REQUESTING THE NIA ADMINISTRATOR GEN. RICARDO R. VISAYA (RET.), EDSA, DILIMAN, QUEZON CITY, TO ALLOCATE FUNDS IN THE AMOUNT OF THIRTY MILLION PESOS (P30,000,000.00) FOR THE RESTORATION AND REHABILITATION OF THE HAPID IRRIGATION SYSTEM, A PRIORITY PROJECT, IN THE MUNICIPALITY OF LAMUT, PROVINCE OF IFUGAO

WHEREAS, the Hapid Irrigation System is one of the biggest irrigation systems in this municipality that serves the agricultural lands of nine (9) big barangays of the municipality of Lamut, Ifugao Province;

WHEREAS, one of the problems affecting the produce of farmers is the insufficient water supply caused by the continuous scouring of the irrigation inlet;

WHEREAS, there is an immediate need to rehabilitate the irrigation system to increase the inflow of water and to sustain the livelihood of the farmers;

WHEREAS, the concerted efforts of the farmers to address the problem is not enough due to lack of machinery, thus, the need for funding from outside sources;

NOW THEREFORE, on motion of SB Member Napoleon C. Belingon, duly seconded, and upon unanimous vote, be it;

RESOLVED, to earnestly request the NIA Administrator Gen. Ricardo R. Visaya (ret.), EDSA, Diliman, Quezon City, to allocate funds in the amount of Thirty Million Pesos (P30,000,000.00) for the Restoration and Rehabilitation of the Hapid Irrigation System, a priority project, in the Municipality of Lamut, Province of Ifugao;

RESOLVED FINALLY, that this Resolution be forwarded to the NIA Administrator Gen. Ricardo R. Visaya (ret.), EDSA, Diliman, Quezon City for his information and basis of appropriate action.
