EARNESTLY REQUESTING SECRETARY EMMANUEL F. PIÑOL, DEPARTMENT OF AGRICULTURE, DILIMAN, QUEZON CITY, TO ALLOCATE FUNDS IN THE AMOUNT OF THIRTY FIVE MILLION PESOS (P35,000,000.00) FOR THE IMPROVEMENT OF PRIORITY FARM-TO-MARKET ROADS IN THE MUNICIPALITY OF LAMUT, PROVINCE OF IFUGAO

WHEREAS, this Body considers Farm-to-Market Roads very important infrastructures that should be maintained to ensure and sustain the socio-economic development of the barangays;

WHEREAS, the Farm-to-Market Roads are priority projects of this municipality. In fact, these are included in the Annual Investment Plan (AIP) and the Local Development Investment Plan (LDIP) of this Local Government Unit;

WHEREAS, these Farm-to-Market Roads require considerable amount which this municipality is incapable of addressing due to its meager financial resources;

NOW THEREFORE, on motion of SB Member Pio K. Famorca, Jr., duly seconded and upon unanimous vote, be it;

RESOLVED, to earnestly request Secretary Emmanuel F. Piñol, Department of Agriculture, Diliman, Quezon City, to allocate funds in the amount of Thirty Five Million Pesos (**PhP35,000,000.00**) for the improvement of the following priority Farm-to-Market Roads in the Municipality of Lamut, Province of Ifugao:

- a. Alupapan-Compra Road (P5,000,000.00)
- b. Solang-Pieza (P5,000,000.00)
- c. Purok 2, Ambasa (P5,000,000.00)
- d. Purok 1, Salamague (P5,000,000.00)
- e. Umilag (P5,000,000.00)
- f. Sanafe (P5,000,000.00)

RESOLVED FURTHER, to earnestly request that the amount or fund be downloaded directly to the Local Government Unit of Lamut, Ifugao Province;

RESOLVED FINALLY, that this Resolution be forwarded to Secretary Emmanuel F. Piñol, Department of Agriculture, Diliman, Quezon City for his information and basis of appropriate action.
