**AUTHORIZING MUNICIPAL MAYOR, ATTY. MARIANO B. BUYAGAWAN, JR., TO ENTER INTO A DEED OF CONDITIONAL DONATION (DOCD) WITH THE BUREAU OF INTERNAL REVENUE (BIR) OR ITS AUTHORIZED REPRESENTATIVE TO DONATE A PARCEL OF LAND AT THE NEW MARKET SITE LOCATED AT MABATOBATO, THIS MUNICIPALITY FOR THE CONSTRUCTION OF A BIR PROVINCIAL OFFICE**

**WHEREAS**, the Bureau of Internal Revenue, represented by Douglas A. Rufino, Assistant Regional Director, requested the Municipal Government of Lamut to donate a parcel of land at the New Market Site located at barangay Mabatobato, this municipality for the construction of a Provincial Office;

**WHEREAS**, after a thorough review and considering the merits of housing the BIR Provincial Office in the municipality, this august Body was convinced that the construction of said office would conveniently serve the constituents of the municipality;

**WHEREAS**, the donation of a parcel of lot by the Municipal Government of Lamut is in accordance to Section 12 of Republic Act 7160 or known as the Local Government Code of 1991 which states that "Provinces, cities, and municipalities shall endeavor to establish a government center where offices, agencies, or branches of the National Government, Local Government Units, or Government-Owned or Controlled Corporations may, as far as practicable, be located."

**NOW THEREFORE**, on motion of SB Member Joseph G. In-uyay, duly seconded, and upon unanimous vote, be it;

**RESOLVED** to authorize Atty. Mariano B. Buyagawan, Jr., Municipal Mayor, to enter into a Deed of Conditional Donation (DOCD) with the Bureau of Internal Revenue (BIR) or its Authorized Representative to donate a parcel of land at the New Market Site located at Mabatobato, this municipality for the Construction of a BIR Provincial Office;

**RESOLVED FURTHER**, that the area to be donated by the municipal government shall not exceed Three Hundred (300) square meters and that the Deed of Conditional Donation (DOCD) shall be rescinded after two (2) years if the construction of said office will not be undertaken;

**RESOLVED FINALLY**, to forward this Resolution to the Municipal Mayor, Atty. Mariano B. Buyagawan, Jr., for his reference and appropriate action.
