REPEALING THE DEED OF CONDITIONAL DONATION ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF LAMUT REPRESENTED BY THE MUNICIPAL MAYOR, ATTY. MARIANO B. BUYAGAWAN, JR. AND THE BUREAU OF FIRE PROTECTION – CORDILLERA ADMINISTRATION REGION REPRESENTED BY SSUPT. MARIA SOFIA B. MENDOZA

WHEREAS, the Sangguniang Bayan, through the request of the Municipal Mayor, authorized the Municipal Local Government Unit represented by Atty. Mariano B. Buyagawan, Jr, to enter into a Deed of Conditional Donation with the Bureau of Fire Protection – Cordillera Administrative Region represented by SSUPT. Maria Sofia B. Mendoza on January 31, 2017;

WHEREAS, paragraph 10 of the Deed of Conditional Donation, states: “That the construction of said office shall be made possible within one (1) year after date and should be constructed by any qualified Lamut Bidder or Contractors in compliance of the regular procurement process of the Government”;

WHEREAS, the Bureau of Fire Protection failed to observe the above-stated condition, hence, it is a justifiable ground to rescind the Deed of Conditional Donation;

WHEREFORE, on motion of SB Member Joseph G. In-uyay, duly seconded, be it;

RESOLVED, to repeal the Deed of Conditional Donation entered into by and between the Municipal Government of Lamut represented by the Municipal Mayor, Atty. Mariano B. Buyagawan, Jr. and the Bureau of Fire Protection – Cordillera Administration Region represented by SSUPT. Maria Sofia B. Mendoza;

RESOLVED FINALLY, to forward a copy of this Resolution to the Office of the Municipal Mayor, Atty. Mariano B. Buyagawan, Jr., the Municipal and Provincial Bureau of Fire Protection, all in this Municipality and the Regional Bureau of Fire Protection – Cordillera Administrative Region, Baguio City, for their information.
