DECLARING OPERATIVE IN ITS ENTIRETY APPROPRIATION ORDINANCE NO. 2-2018 OF BARANGAY NAYON, MUNICIPALITY OF LAMUT, PROVINCE OF IFUGAO COVERING VARIOUS EXPENDITURES OF THE BARANGAY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2-2018 of Barangay Nayon, Municipality of Lamut, Province of Ifugao authorizing its Supplemental Budget for Fiscal Year 2018 involving an amount of One Hundred Fifty-Seven Thousand Three Hundred Seven Pesos (P157,307.00) was submitted to the Sangguniang Bayan for review pursuant to Republic Act 7160;

WHEREAS, the subject Appropriation Ordinance has substantially complied with the budgetary requirements and general limitation as well as other provision of law;

NOW THEREFORE, on motion of SB Member Pio K. Famorca, Jr., duly seconded and upon unanimous vote, be it;

RESOLVED, to declare operative in its entirety Appropriation Ordinance No. 2-2018 of Barangay Nayon, Municipality of Lamut, Province of Ifugao subject to the following conditions:

1. All funded Programs/Projects/Activities (PPAs) must be found in the approved Annual Investment Program (AIP);
2. The review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of laws and budgeting circulars;
3. The implementation of all Programs/Projects/Activities (PPAs) must be in accordance to budget rules and regulations.

RESOLVED FINALLY, to forward copies of this resolution to the Sangguniang Barangay of Nayon through the Municipal Budget Officer, Office of the Municipal Mayor and other concerned offices for their information and guidance.
