**DECLARING OPERATIVE IN ITS ENTIRETY APPROPRIATION ORDINANCE NO. 01-2018 OF BARANGAY PAYAWAN, MUNICIPALITY OF LAMUT, PROVINCE OF IFUGAO COVERING VARIOUS EXPENDITURES OF THE BARANGAY SUBJECT TO SOME CONDITIONS**

**WHEREAS**, Appropriation Ordinance No. 01-2018 of Barangay Payawan, Municipality of Lamut, Province of Ifugao authorizing its Supplemental Budget for Fiscal Year 2018 involving an amount of Eighty-Eight Thousand Eighty-One Pesos & 06/100 (P88,081.06) was submitted to the Sangguniang Bayan for review pursuant to Republic Act 7160;

**WHEREAS**, the subject Appropriation Ordinance has substantially complied with the budgetary requirements and general limitation as well as other provision of law;

**NOW THEREFORE**, on motion of SB Member Pio K. Famorca, Jr., duly seconded and upon unanimous vote, be it;

**RESOLVED**, to declare operative in its entirety Appropriation Ordinance No. 01-2018 of Barangay Payawan, Municipality of Lamut, Province of Ifugao subject to the following conditions:

1. All funded Programs/Projects/Activities (PPAs) must be found in the approved Annual Investment Program (AIP);
2. The review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of laws and budgeting circulars;
3. The implementation of all Programs/Projects/Activities (PPAs) must be in accordance to budget rules and regulations.

**RESOLVED FINALLY**, to forward copies of this resolution to the Sangguniang Barangay of Payawan through the Municipal Budget Officer, Office of the Municipal Mayor and other concerned offices for their information and guidance.
