AUTHORIZING ATTY. MARIANO B. BUYAGAWAN, JR., MUNICIPAL MAYOR, THIS MUNICIPALITY, TO DONATE FIVE HUNDRED (500) SQUARE METERS OF LOT INSTEAD OF THREE HUNDRED (300) SQUARE METERS FROM THE PROPOSED TOURISM VILLAGE OF THE MUNICIPAL GOVERNMENT LOCATED AT BANTING, MABATOBATO, THIS MUNICIPALITY, TO THE BUREAU OF INTERNAL REVENUE (BIR) FOR THE CONSTRUCTION OF A PROVINCIAL DISTRICT OFFICE

WHEREAS, forwarded for consideration is the letter request of Atty. Mariano B. Buyagawan, Jr., Municipal Mayor, this municipality, requesting for One Thousand (1,000) square meters to be donated to the BIR for the Construction of a four (4) storey building to be used by the Bureau as their Provincial District Office;

WHEREAS, the Sangguniang Bayan has earlier authorized the Local Chief Executive, Atty. Mariano B. Buyagawan, Jr., to donate three hundred (300) square meters from the proposed Tourism Center of the Municipal Government to the BIR for the construction of a District Office;

WHEREAS, the approved building plan which was attached to the request and presented to the august Body has an actual dimension of three hundred (300) sq. meters with a reserve of two hundred for their improvements;

WHEREAS, the establishment of a BIR District Office in the municipality would be beneficial to resident tax payers considering the travel time and the risk of going to the District Office in Lagawe;

NOW THEREFORE, on motion of SB member Joseph G. In-uyay, duly seconded severally and upon unanimous vote, be it;

RESOLVED, to authorize Atty. Mariano B. Buyagawan, Jr., Municipal Mayor to donate five hundred (500) square meters of lot instead of three hundred (300) square meters from the proposed Municipal Tourism Center of the Municipal Government located at Banting Mabatobato to the Bureau of Internal Revenue for the construction of a District Office;

RESOLVED FURTHER, that the five hundred (500) square meters to be donated shall be used solely for the Construction of a Provincial District Office;

RESOLVED FURTHERMORE, that the Conditional Deed of Donation shall be automatically revoked/rescinded if the construction does not commence up to the end of year 2021;

RESOLVED FINALLY, to furnish copies of this Resolution to the Office of the Municipal Mayor, this municipality for his basis of action.
