AUTHORIZING THE MUNICIPAL MAYOR, ATTY. MARIANO B. BUYAGAWAN, JR., TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRICULTURE-REGIONAL OFFICE CORDILLERA ADMINISTRATIVE REGION AND SIGN OTHER RELATED DOCUMENTS IN BEHALF OF THE MUNICIPALITY

WHEREAS, the Department of Agriculture-Regional Field Office Cordillera Administrative Region (DA-RFO-CAR), with postal address at BPI Compound, Guisad, Baguio City represented by its Regional Director, Narciso A. Edillo, MA. Ed, is tasked to establish "Organic Trading Post (OTP)" in strategic areas to strengthen the adoption and practice of Organic Agriculture as mandated by Republic Act No. 10068;

WHEREAS, the Local Government Units, too, are mandated to establish at least one Organic Trading Post (OTP), thus, this Municipality signified its intention with the submission of documents which were evaluated and validated and found qualified by proper authorities of the Department of Agriculture;

WHEREAS, the DA-RFO-CAR shall provide funds amounting to Two Million Pesos (P2,000,000.00) and the LGU shall provide a counterpart of Four Hundred Thousand Pesos (P400,000.00) for the purchase of needed facilities and Three Hundred Thousand Pesos (P300,000.00) for initial capital to immediately operate the OTP;

WHEREAS, after careful study of the Memorandum of Agreement, this august Body unanimously agree that it bears merit and is meritorious for the people of Lamut;

NOW THEREFORE, on motion of SB Member Joseph G. In-uyay, duly seconded, and upon unanimous vote, be it:

RESOLVED, to authorize the Municipal Mayor, Atty. Mariano B. Buyagawan, Jr., to enter into a Memorandum of Agreement with the Department of Agriculture-Regional Office Cordillera Administrative Region and sign other related documents in behalf of the municipality.

RESOLVED FINALLY, to forward copies of this Resolution to the Office of the Municipal Mayor and all offices concerned, for their reference.
