AUTHORIZING SUPPLEMENTAL BUDGET NO. 03, SERIES OF 2018 INVOLVING AN AMOUNT OF TWO MILLION FIFTY THOUSAND PESOS (PHP 2,050,000.00) FOR THE PAYMENT OF NEGOTIATION AGREEMENT (CNA) INCENTIVES OF MUNICIPAL OFFICIALS AND EMPLOYEES FOR FISCAL YEAR 2018

Be it ordained by the Sangguniang Bayan of the Municipality of Lamut, Ifugao Province in Regular Session assembled this 28th day of December 2018:

Section 1. The Supplemental Budget No. 3 of the Municipal Government of Lamut for Fiscal Year 2018 of **Two Million Fifty Thousand Pesos (P2,050,000.00)** is hereby approved.
