**MUNICIPAL ORDINANCE NO. 2018-18-002**

*(Sponsored by the Committee on Tourism and Institutional Linkages and External Affairs)*

**NAMING THE MUNICIPAL ECO-PARK AS ZOSIMO J. PAREDES, SR. MUNICIPAL  
ECO-PARK LOCATED AT SANAFE, LAMUT, PROVINCE OF IFUGAO**

**EXPLANATORY NOTE**

The heir of Zosimo J. Paredes, Mr. Renato M. Paredes executed a conditional Absolute Waiver of Rights over a parcel of land at Sanafe in favor of the Municipality of Lamut, Province of Ifugao.

R.A. 7160, otherwise known as the Local Government Code of 1991, specifically Rule IV, Article 22, (b) and (e) and Article 23, (c), 7 provides power to the Sanggunians of component cities and municipalities, in consultation with the National Historical Institute (NHI), to name any public places or building within the territorial jurisdiction of the municipality.

Pursuant to the above-stated provisions and in recognition and honor of the valuable and significant contributions of Zosimo J. Paredes as former Provincial Governor of the Province of Ifugao to the general welfare and development of the municipality of Lamut as well as the Province of Ifugao, it is but proper and in order to enact this Ordinance.

Be it ordained by the Sangguniang Bayan in session assembled that:

**SECTION 1. TITLE** - This Ordinance shall be known and cited as "An Ordinance Naming Municipal Eco-Park as Zosimo J. Paredes, Sr. Municipal Eco-Park."

**SECTION 2. DECLARATION OF POLICY** - it shall be a declared policy of this Municipality to recognize with due respect and honor the priceless contribution of Zosimo J. Paredes, Sr. for the general welfare and development of this Municipality as former provincial official of this Province and as donor of a parcel of land.

**SECTION 3. NAMING OF THE MUNICIPAL ECO-PARK AS ZOSIMO J. PAREDES, SR. MUNICIPAL PARK.** The Zosimo J. Paredes, Sr. Municipal Eco-Park is located at Sanafe, Lamut, Ifugao containing a total of Two Hundred Eighty Thousand Seven Hundred Twenty Seven (280,727) square meters intended for the development of municipal Eco-Park.

**SECTION 4. SEPARABILITY CLAUSE** - Any provision or portion of this Ordinance to be violative of the Constitution or invalid, shall not impair the other provisions or parts thereof which shall continue to be in force and in effect.

**SECTION 5. EFFECTIVITY** - This Ordinance shall take effect upon approval.
