LOCALIZING AND INSTITUTIONALIZING THE RED ORCHID AWARD IN THE MUNICIPALITY OF LAMUT, PROVINCE OF IFUGAO AND PROVIDING FUNDS FOR THE PURPOSE

EXPLANATORY NOTE

The Local Government of Unit of Lamut has been a recipient of the Red Orchid Award for three (3) consecutive years and is now a hall of famer. This success by the LGU is because of the consolidated effort of all stakeholders in the community most especially that of the barangays.

It is, therefore, best fitting that the National Red Orchid Award should be localized and institutionalized in order that the efforts of the barangays be recognized. This is also one way of sustaining the program of the MLGU in the implementation of its Anti-Smoking Policy.

SECTION 1. TITLE. This Ordinance shall be known as the Lamut Red Orchid Award Ordinance.

SECTION 2. DECLARATION OF POLICY. Recognizing the efforts of the Barangay Governments in promoting a healthy environment for the people, it shall be the policy of the Municipal Government of Lamut, Ifugao to enhance the capabilities of the Barangays by providing them with the opportunity to participate actively in the implementation of national programs as provided for under Section 3(g) of RA 7160.

SECTION 3. AWARD. The Barangay Red Orchid Award shall be awarded to every barangay who shall qualify or meet the criteria to be set by the Barangay Red Orchid Award Committee and shall be given the following:

1. A PLAQUE recognizing the barangay as an awardee of the Barangay Red Orchid Award; and
2. Cash Prizes

- 2.1. Fifty Thousand Pesos (Php 50,000.00) for the most outstanding Barangay
- 2.2. Thirty Thousand Pesos (P30,000.00) for the second place
- 2.3. Twenty Thousand Pesos (P20,000.00) for the third place
- 2.4. Consolation prizes of Five Thousand Pesos (P5,000.00) each for participating barangays who qualified

The utilization of prizes should be used for projects and activities of the Barangay relevant to this program.

SECTION 4. DEFINITION OF TERMS. As used in this Ordinance, the following shall mean:

- a. Red Orchid Award - it is a recognition given and awarded to Barangays in the Municipality of Lamut that are strictly enforcing the tobacco control and regulating measures in promotion of 100% tobacco-free environment in their area of jurisdiction

SECTION 5. BARANGAY RED ORCHID AWARD COMMITTEE. The Barangay Red Orchid Award Committee shall be composed of the following:

1. Municipal Health Officer - Chairperson
2. Municipal Environment and Natural Resources Officer - Vice Chairperson
3. Municipal Planning and Development Officer - Member
4. DILG Municipal Coordinator - Member
5. SK Municipal Federation President - Member
6. Philippine National Police Representative - Member
7. Non-Government Organization Representative - Member

SECTION 6. POWERS AND FUNCTION. The following shall be the powers and functions of the Barangay Red Orchid Award Committee:

1. formulate the guidelines and criteria for the award;
2. conduct quarterly inspection and evaluation of participating barangays based on the guidelines and criteria formulated;
3. determine and declare the qualified barangays for the Barangay Red Orchid Award and submit the final list to the Municipal Mayor for approval;
4. make recommendations to the Sangguniang Bayan for legislations relative to the Anti-Smoking Policy of the Municipal Local Government Unit; and
5. conduct meetings relative to their functions hereto.

SECTION 7. IMPLEMENTING RULES AND REGULATIONS. The Municipal Mayor may formulate additional implementing rules and regulations relative to this ordinance for its proper implementation.

SECTION 8. AWARDING. The Barangay Red Orchid Award together with the Plaque and Cash Prize shall be awarded during the Annual Foundation Day and Municipal Fiesta Celebration.

SECTION 9. APPROPRIATION. The Municipal Local Government of Lamut shall allocate the amount of Two Hundred Thousand Pesos (Php200,000.00) from the General Fund for the proper implementation of this Ordinance. The Barangay Red Orchid Award Committee may recommend a supplementary amount when necessary.

SECTION 10. SEPARABILITY CLAUSE. All municipal ordinances or parts of any municipal ordinance found to be inconsistent with existing laws shall not render the entire ordinance invalid, provisions that can be implemented on their own shall be fully implemented.

SECTION 11. REPEALING CLAUSE. All municipal ordinances or parts of any municipal ordinance inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 12. EFFECTIVITY. This Ordinance shall take effect after compliance with the requirement of posting as set forth under the Local Government Code of 1991.
