EARNESTLY REQUESTING THE DEPARTMENT OF ENERGY THRU SECRETARY ALFONSO G. CUSI FOR FUNDING OF THE INSTALLATION OF SOLAR STREET LIGHT ALONG THE NATIONAL HIGHWAY (POBLACION WEST TO NAYON AND POBLACION WEST TO PANOPDOPAN) AMOUNTING TO TWENTY MILLION PESOS (P20,000,000.00)

WHEREAS, the provincial roads of Barangays Nayon and Panopdopan are two of the busiest roads in the municipality as they traverse an educational center (IFSU) and three barangays (Mabatobato, Lawig, Luchan), respectively;

WHEREAS, the installation of solar street lights not only on major thoroughfares but also on roads leading to the barangays would conveniently serve motorists for better visibility during the night, even on blackouts, and to prevent imminent accidents. Moreover, its usage yields lesser electricity expenses for the municipality;

NOW THEREFORE, on motion of SB Member Maria Victoria Grace G. Macadaeg, duly seconded and upon unanimous vote, be it;

RESOLVED, to earnestly request the Department of Energy thru Secretary Alfonso G. Cusi for funding of the Installation of Solar Street Light along the National Highway (Poblacion West to Nayon and Poblacion West to Panopdopan) amounting to Twenty Million Pesos (P20,000,000.00);

RESOLVED FURTHER, to earnestly request that the amount or fund be downloaded directly to the Local Government Unit of Lamut, Ifugao Province;

RESOLVED FINALLY, that this Resolution be forwarded to Secretary Alfonso G. Cusi, Department of Energy, Bonifacio Global City, Taguig City for his information and basis of appropriate action.
