AUTHORIZING ATTY. MARIANO B. BUYAGAWAN, JR., MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE ALUPAPAN INTEGRATED SCHOOL FOR WORK IMMERSION PARTNERSHIP

WHEREAS, the Department of Education (DepED) has introduced the K to 12 basic education reform program that includes Senior High School, with the major objective of ensuring that graduates of basic education are ready for employment, entrepreneurship and higher learning;

WHEREAS, the Alupapan Integrated School located at Pugol, Lamut, Ifugao in adherence to DepED's objective, needs to enter into a Work Immersion partnership with the LGU;

WHEREAS, the LGU recognizes the need for a work immersion environment that is safe for the students and teachers, and conducive to learning, and has the capability to provide these;
