AUTHORIZING ATTY. MARIANO B. BUYAGAWAN, JR., MUNICIPAL MAYOR TO ALLOCATE TEN THOUSAND EIGHT HUNDRED EIGHTY ONE (10,881) SQUARE METERS FROM THE MUNICIPAL SPORTS COMPLEX SITE, AT BANTING, POBLACION WEST, LAMUT, IFUGAO TO THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY, LAGAWE, IFUGAO FOR THE ESTABLISHMENT OF A SATELLITE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT (TESD) CENTER FOR CLIENTS OF THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY

WHEREAS, forwarded for consideration is the letter request of Atty. Mariano B. Buyagawan, Jr., Municipal Mayor, this municipality, requesting for an SB authorization to donate a parcel of land from the Municipal Sports Complex located at Banting, Poblacion West, Lamut, Ifugao to the Technical Education and Skills Development Authority, Lagawe, Ifugao;

WHEREAS, the request letter emanated from a resolution adopted by the Provincial Technical Education Skills Development Committee (PTESDC) - Ifugao approved on the 22nd day of March, 2018 at Lagawe, Ifugao under Resolution No. 02, Series of 2018;

WHEREAS, the parcel of land containing an area of more or less fifty (50) thousand sq. meters is still under Presidential Decree 105 and in possession of the Municipal Government through a waiver executed by Mr. Rosito Malingan who was the original occupant of that land;

WHEREAS, an application for ownership was already submitted to the Department of Environment and Natural Resources (DENR), Central Office for appropriate action; and

WHEREAS, considering the merit of the resolution of the PTESDC-Ifugao and the benefits of the clients and the constituents of the municipality in particular, this august Body favorably grants the request of the PTESDC

NOW THEREFORE, on motion of SB Member Joseph G. In-uyay, duly seconded, and upon unanimous vote, be it;

RESOLVED, to authorize Atty. Mariano B. Buyagawan, Jr., Municipal Mayor to allocate Ten Thousand Eight Hundred Eighty Eight One (10,881) square meters to the Technical Education and Skills Development Authority, Lagawe, Ifugao for the establishment of a Satellite Technical Education and Skills Development Center;

RESOLVED FURTHER, that the parcel of land to be allocated to PTESDC shall only be used for the establishment of a Satellite Technical Education and Skills Development Center. A deed of donation shall be signed by both parties as soon as the right of ownership is granted by the Department of Environment and Natural Resources or any other concerned agencies.

RESOLVED FURTHERMORE, that the right of allocation shall be rescinded after two (2) years if no funding is made and development activities will commence. Additional terms and conditions may also be provided that is beneficial to both parties;

RESOLVED FINALLY, to furnish copies of this Resolution to the Technical Education And Skills Development Authority, Lagawe, Ifugao and the Office of the Municipal Mayor, this municipality for their basis of action.
